## Memorandum of Understanding (MoU)

**Arni University, Indora, Himachal Pradesh** and **Shri J.J.T. University, Chudela, Jhunjhunu, Rajasthan, India** wishing to establish relations between the two universities, agree to cooperate with each other as follows.

Subject to mutual consent, the areas of cooperation will include any program offered at either institution as thought desirable and feasible on either side and that both sides will contribute to the fostering and development of the cooperative relationship between the two universities. Cooperation shall be carried out through such activities as:

1. Exchange of faculty and/ or staff
2. Exchange of students
3. Joint research activities and publications
4. Participation in seminars and academic meetings
5. Exchange of academic materials and other information
6. Special short-term academic program

The terms of cooperation for each specific activity implemented under this MoU for Cooperation shall be mutually discussed and agreed upon in writing by both universities prior to the initiation of that activity. Any such MoUs entered into as outlined above, will form appendices to this MoU for Cooperation.

The two universities hereby agree on the following articles to establish the Exchange Program.

### STUDENT EXCHANGE

1. The aim of the exchange program is to provide students an opportunity to have experience of broad level national cooperation and exchange, as well

- Any amendment or modification to the present text shall be submitted for review to the competent authorities, and shall not binding unless reduced to writing and signed by both the universities.


