WHEREAS, both parties recognize the mutual benefits of establishing a strategic partnership in the areas of training, skill development, and internship programs;

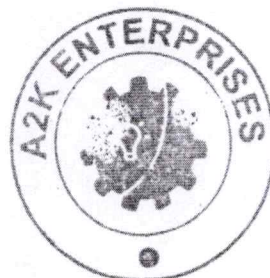
NOW, THEREFORE, the University and the Company hereby agree to enter into this MOU under the following terms and conditions:

4. Responsibilities of the Company:

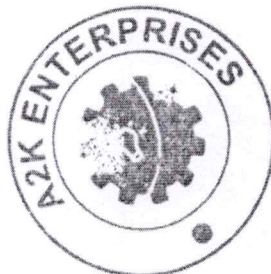
a. The Company will participate in the University's placement drives and conduct recruitment processes to select candidates for employment.

7. Governing Law:

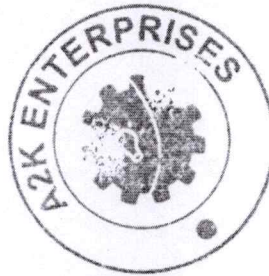
This MOU shall be governed by and construed in accordance with the laws of [Governing Jurisdiction of Maharashtra].
