Memorandum of Understanding (MOU)

This Memorandum of Understanding (MOU) is made and entered into this 18-02-2021 by **and** between Shri Jagdishprasad Jhabarmal Tibrewala University, located at Churu Rd, Vidyanagari, Churela, Jhunjhunu, Rajasthan 333001, represented by Dr. Madhu Gupta, Registrar, SJJTU. hereinafter referred to as "University,"

and

CHDNLR (Centre for Human Development and Neuro Linguistics Research), located at U Building, 1st Floor, Dana Bandar, APMC Plot No 7, near RTO, Sector 19B, Vashi, Navi Mumbai, Maharashtra, represented by Dr.Swati — Vice President, hereinafter referred to as "Company."

WHEREAS, both parties acknowledge the importance of fostering collaboration to enhance the skills and employability of students and graduates;

WHEREAS, both parties recognize the mutual benefits of establishing a strategic partnership in the areas of training, skill development, and internship programs;

NOW, THEREFORE, the University and the Company hereby agree to enter into this MOU under the following terms and conditions:

1. Purpose and Scope:

The primary objective of this MOU is to establish a cooperative framework between the University and the Company to focus on the following areas:

- a. Training and Placement: The Company agrees to actively participate in the University's campus recruitment drives and offer suitable employment opportunities to qualified graduates.
- b. Skill Development: The University and the Company will collaborate to design and deliver skill development programs that align with industry demands and enhance the employability of students.
- c. Training: The Company will provide training sessions, workshops, and seminars to the students, focusing on industry-specific knowledge and practical skills.
- d. Internship Programs: The Company will offer internship opportunities to select students, providing valuable real-world experience in the relevant fields.

2. Duration:

This MOU shall be in effect for a period of 24 months from the date of signing, unless terminated earlier by mutual agreement or by either party with a prior notice of 30 days.

3. Responsibilities of the University:

- a. The University will identify and recommend suitable students for training and placement opportunities provided by the Company.
- b. The University will facilitate and support the organization of workshops, seminars, and other skill development initiatives in coordination with the Company.

6. Modification and Termination:

Any modification or amendment to this MOU shall be made in writing and signed by authorized representatives of both parties. Either party may terminate this MOU with a prior written notice of 30 days to the other party.

7. Governing Law:

This MOU shall be governed by and construed in accordance with the laws of [Governing Jurisdiction].
