**Memorandum of Understanding (MOU)**

This Memorandum of Understanding (MOU) is made and entered into this 08/01/2021 by and between Shri Jagdishprasad Jhabarmal Tibrewala University (SJTU), Vidyanagri, Jhunjhunu Bisau Road, Chudela, District - Jhunjhunu, Rajasthan -333010, represented by Dr. Madhu Gupta, Registrar, SJTU, hereinafter referred to as "University,"

and

SGA Tech Projects Consultancy Pvt. Ltd., located at F4 First Floor Sudarsan Ruby No 85 6th Main, 13th Cross Appareddy Palya, Indiranagar 2nd Stage, Bangalore - 560038, Karnataka, India, represented by Syed Aafaq Hussain, Managing Director, hereinafter referred to as "Company."

WHEREAS, both parties acknowledge the importance of fostering collaboration to enhance the skills and employability of students and graduates;

WHEREAS, both parties recognize the mutual benefits of establishing a strategic partnership in the areas of training, skill development, and internship programs;

NOW, THEREFORE, the University and the Company hereby agree to enter into this MOU under the following terms and conditions:

1. Purpose and Scope:

The primary objective of this MOU is to establish a cooperative framework between the University and the Company to focus on the following areas:

- a. Training and Placement: The Company agrees to actively participate in the University's campus recruitment drives and offer suitable employment opportunities to qualified graduates.





b. Skill Development: The University and the Company will collaborate to design and deliver skill development programs that align with industry demands and enhance the employability of students.

c. Training: The Company will provide training sessions, workshops, and seminars to the students, focusing on industry-specific knowledge and practical skills.

d. Internship Programs: The Company will offer internship opportunities to select students, providing valuable real-world experience in the relevant fields.

## 2. Duration:

This MOU shall be in effect for a period of 24 months from the date of signing, unless terminated earlier by mutual agreement or by either party with a prior notice of 30 days.

## 3. Responsibilities of the University:

a. The University will identify and recommend suitable students for training and placement opportunities provided by the Company.

b. The University will facilitate and support the organization of workshops, seminars, and other skill development initiatives in coordination with the Company.

## 4. Responsibilities of the Company:

a. The Company will participate in the University's placement drives and conduct recruitment processes to select candidates for employment.

b. The Company will actively engage in training sessions and provide mentorship to the students during internships.

c. The Company will collaborate with the University to develop and deliver relevant skill development programs.
