- b Skill Development: The University and the Company will collaborate to design and deliver skill development programs that align with industry demands and enhance the employability of students.
- c Training: The Company will provide training sessions, workshops, and seminars to the students, focusing on industry-specific knowledge and practical skills.
- d. Internship Programs: The Company will offer internship opportunities to select students, providing valuable real-world experience in the relevant fields.

2. Duration:

This MOU shall be in effect for a period of 24 months from the date of signing, unless terminated earlier by mutual agreement or by either party with a prior notice of 30 days.

- 3. Responsibilities of the University:
- a. The University will identify and recommend suitable students for training and placement opportunities provided by the Company.
- b. The University will facilitate and support the organization of workshops, seminars, and other skill development initiatives in coordination with the Company.
- 4. Responsibilities of the Company:

- c. The Company will collaborate with the University to develop and deliver relevant skill development programs.
