WHEREAS, both parties acknowledge the importance of fostering collaboration to enhance the skills and employability of students and graduates;

WHEREAS, both parties recognize the mutual benefits of establishing a strategic partnership in the areas of training, skill development, and internship programs;

NOW, THEREFORE, the University and the Company hereby agree to enter into this MOU under the following terms and conditions:

### 1. Purpose and Scope:

d. Internship Programs: The Company will offer internship opportunities to select students, providing valuable real-world experience in the relevant fields.

### 2. Duration:

This MOU shall be in effect for a period of 24 months from the date of signing, unless terminated earlier by mutual agreement or by either party with a prior notice of 30 days.

## 3. Responsibilities of the University:

- a. The University will identify and recommend suitable students for training and placement opportunities provided by the Company.
- b. The University will facilitate and support the organization of workshops, seminars, and other skill development initiatives in coordination with the Company.

## 4. Responsibilities of the College:

- a. The College will participate in the University's placement drives and conduct recruitment processes to select candidates for employment.
- b. The College will actively engage in training sessions and provide mentorship to the students during internships.
- c. The College will collaborate with the University to develop and deliver relevant skill development programs.

### 5. Confidentiality:

Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the collaboration.

#### 6. Modification and Termination:

Any modification or amendment to this MOU shall be made in writing and signed by authorized representatives of both parties. Either party may terminate this MOU with a prior written notice of 30 days to the other party.
