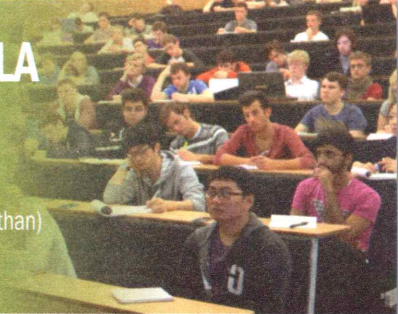

  - A provision for an adjustable fee structure in different courses will be explored to accommodate the anticipated expenses for both organizations.

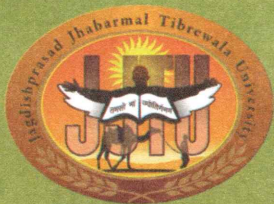

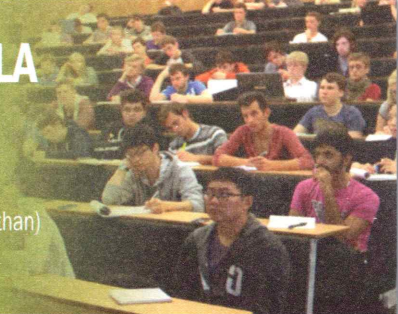

### 5. Confidentiality & Intellectual Property Rights:

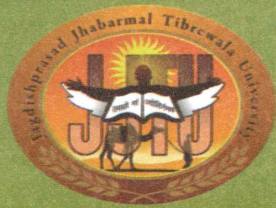
- Any proprietary information shared between the parties shall be kept confidential and used only for the intended purpose of this collaboration.

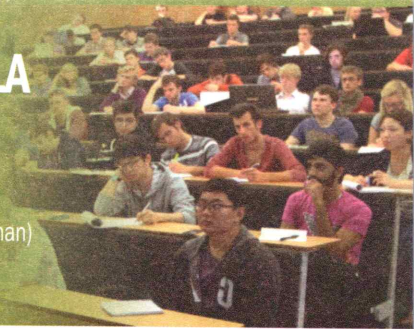
