INSTITUTIONAL SCHOLARSHIP POLICY

Our University considers award of scholarship based on academic merit (+2 cut-off marks at the time of admission), Girl Students, Sportsman, economically weak from rural backward and rural agricultural community of the enrolled students. The policy considers award of one scholarship and/or adjustment toward tuition fee and/or tuition fee waiver to a meritorious and economically poor student per academic year. The selection procedure involves requisition by the meritorious and economically poor enrolled students and consideration of partial tuition waiver to deserving students with special achievements in Sports. The scholarship committee shall be the authority to scrutinize the candidate names for the award of scholarship and/or tuition waiver as applicable.

The Chairperson of Shri Jagdishprasad Jhabarmal Tibrewala University, Chudela, shall be the final authority to approve the award of the scholarship.

SCHOLARSHIP COMMITTEE AND SELECTION PROCEDURE

All scholarship shall be scrutinized at the time of admission by the scholarship selection committee. The scholarship is awarded depending on the annual budget allocation toward scholarship; hence, award amount of scholarship may vary year to year.

ELIGIBILITY CRITERION

All eligible students are required to apply for scholarship at the time of admission. The selection committee may request for additional documents as deemed appropriate. It includes academic records and sports achievement. It is the responsibility of the students to submit all documents along with the scholarship application.

1. Partial/full/tuition fee waiver for specific period/special categories) and duration of scholarship be awarded by Chairperson on time to time

AWARD NOTIFICATION

The scholarship committee shall communicate to the selected candidates and maintain the database of all the awardee candidates and their academic progression & achievements in specific format. The scholarship award clearly mentions the amount, type of scholarship

(partial/full/tuition fee waiver for specific period/special categories) and duration of scholarship. No student shall be allowed to avail more than one scholarship except government scholarship at any point of academic period. The award clearly explains to the awardees the necessary rules and regulations of the award.

SCHOLARSHIP PROGRESSION AND CHARACTER

The student has to maintain discipline and acceptable behaviour as per the Code of Conduct of students during the period of study. A scholarship awardee student under any disciplinary action and/or pending disciplinary action shall result in termination and/or withdrawal of the award. The Student shall maintain satisfactory performance in studies with no backlog. The student also acts as an ambassador of the Institute.

SCHOLARSHIP CATEGORIES

Number of scholarship and/or tuition waiver to be considered in an academic year is subject to change considering allotted Funds, merits of enrolled student, need based consideration of financial support in the form of tuition fee waiver as partial contribution toward scholarship through tuition fee adjustments as per the University guidelines.

Following are guidelines, subjected to change, set by the University to consider award of scholarship and/or any other forms of financial support;

1. One scholarship award is tenable in selected program in an academic year. The scholarship period shall be one year, which is renewable under satisfactory of student performance.
2. The validity of the scholarship duration is pre-decided by the scholarship committee with clear definition on the applicable conditions based certain criterion on student performance in each semester.
3. Tuition fee waiver shall be considered on case-by-case basis for each program.
4. No cash refunds shall be allowed to the scholarship awardees students. The remaining fee shall be made available to students after examining the performance of the students and satisfactory certificate issued by the Dean/Head of the department.
5. All the eligible student/s has to apply for the scholarship at the time of enrolment.

6. The University shall have the right to utilize the scholarship awardees for promotional activities and the awardees shall be ambassadors of the Institute.
7. No student is allowed to hold more than one scholarship except government scholarship at a time, irrespective of type and amount of scholarship and/or study support donations.

SPORTS SCHOLARSHIP & CASH PRIZE SCHEME

ELIGIBILITY CRITERION FOR SPORTS SCHOLARSHIP & CASH PRIZE SCHEME

1. The sports scholarship will be awarded on the basis of performance in recognized competitions held during the previous three academic years.

2. Both prospective as well as bonafide students of SJJT University can apply for the sports scholarship.
3. A student shall not receive any other sports scholarship from any other source. In case any student is already receiving such scholarship, he/she has to surrender that in order to avail the benefits of SJJTU's sports scholarship.
4. The student shall apply only in one sports/games in which he/she has achieved the highest performance during the previous two academic years.
5. The University Sports Committee has the right to decide awarding the scholarships depending on the number of scholarships available for different sports/games.

DURATION OF SPORTS SCHOLARSHIP:

1. Any sports scholarship awarded to a student shall be initially for one year and will be renewable every year provided the awardee is improving /maintaining the proficiency in the sport/game concerned. Exceptions to this policy will be made at the discretion of the sports board only in case of injury, disease, or ill-health provided the student submits relevant documents.
2. A student shall submit a new application on prescribed form for the renewal of scholarship every year failing which it will be stopped even if one is eligible.
3. The form should then be forwarded through the proper channel (Head of Department & President) to the University's Sports Board.

Note:-

In the case of Certificates of Open Tournaments/ Championships

When the tournament / championships should have been officially be recognized as the regular annual championships / tournament, by Ministry of Youth Affairs and Sports (MYAS) or Indian Olympic Association (IOA) or SAI or respective official National Sports Federation will be considered.
