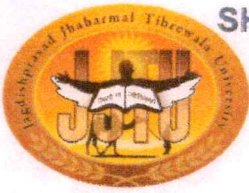

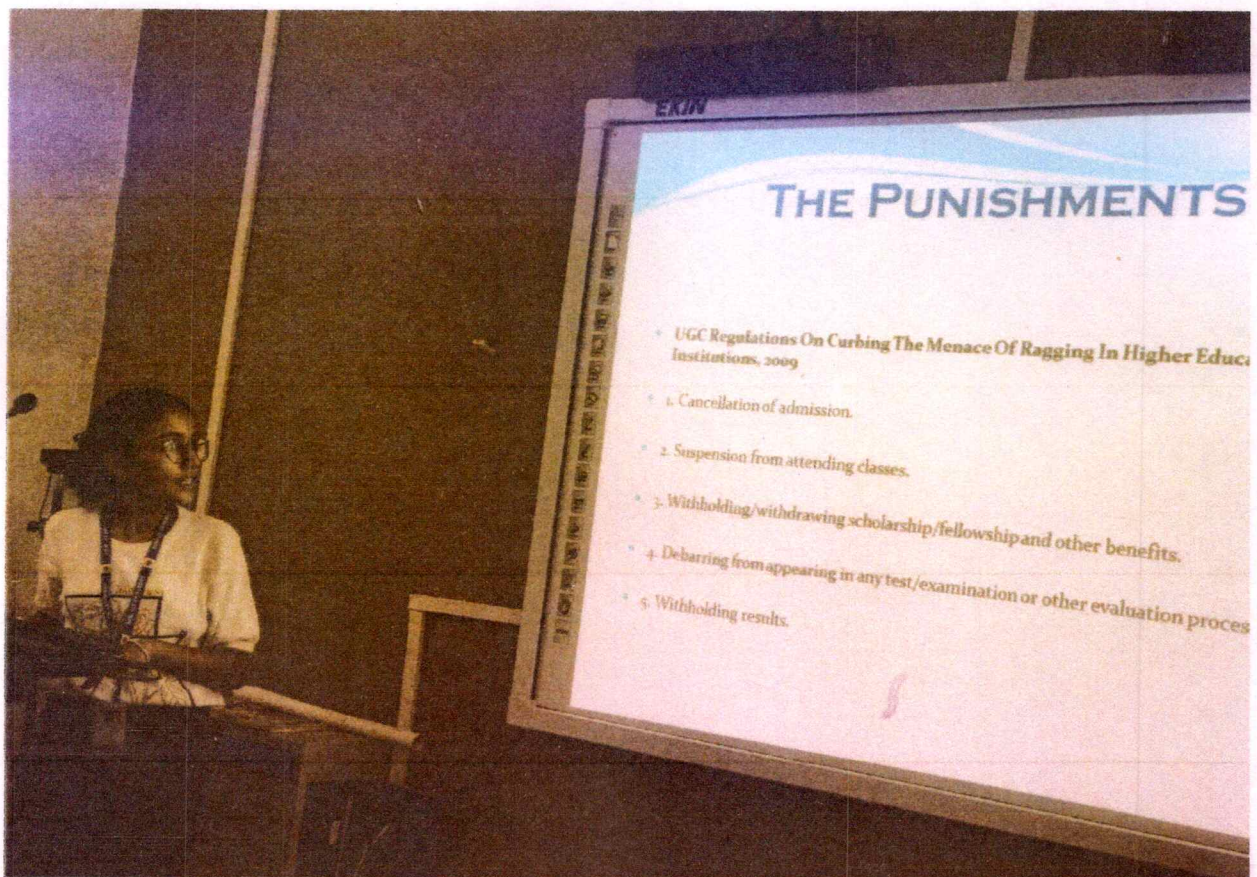


Fig.1 ("Anti Ragging Awareness Program")



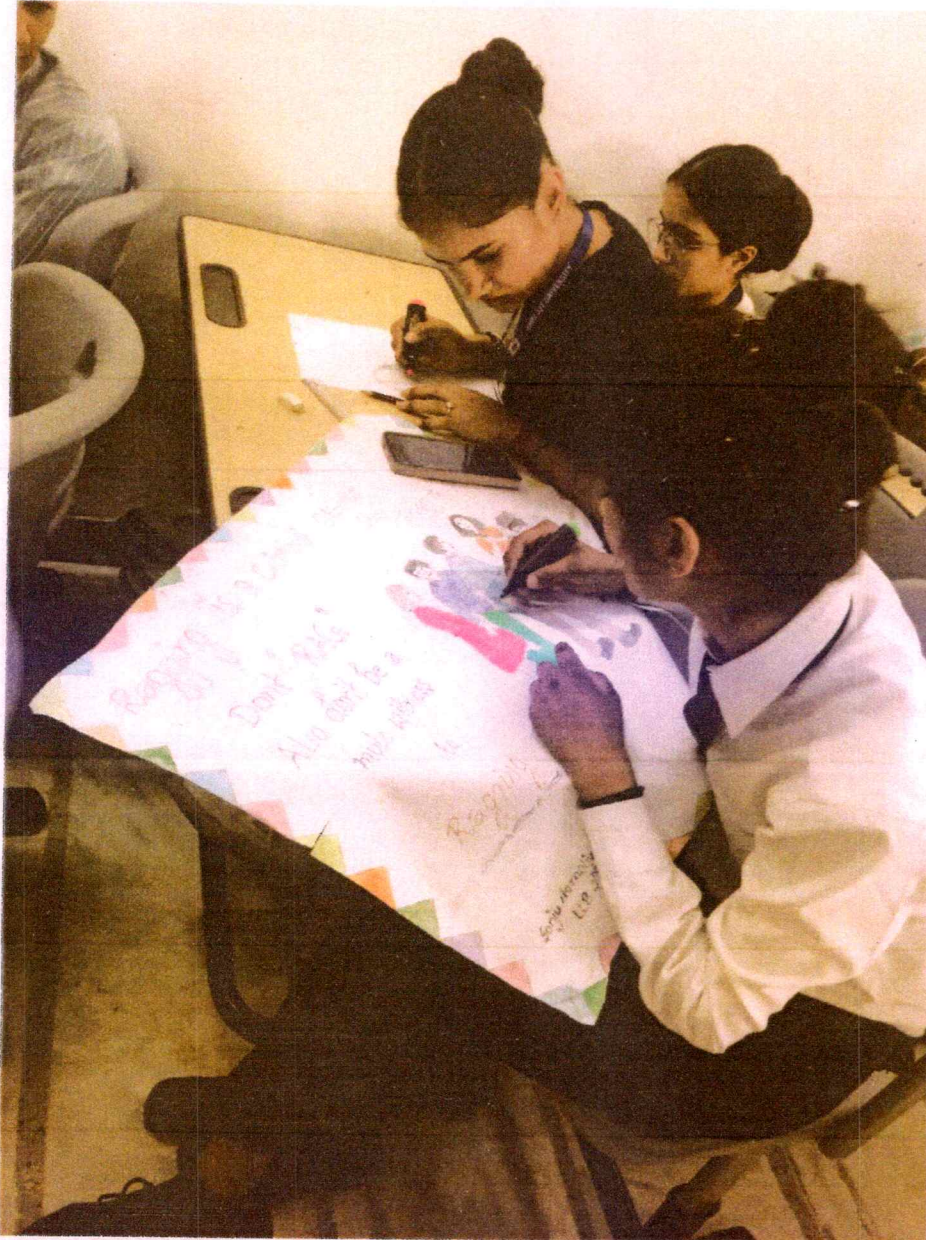


Fig.2 ("Anti Ragging Awareness Program")

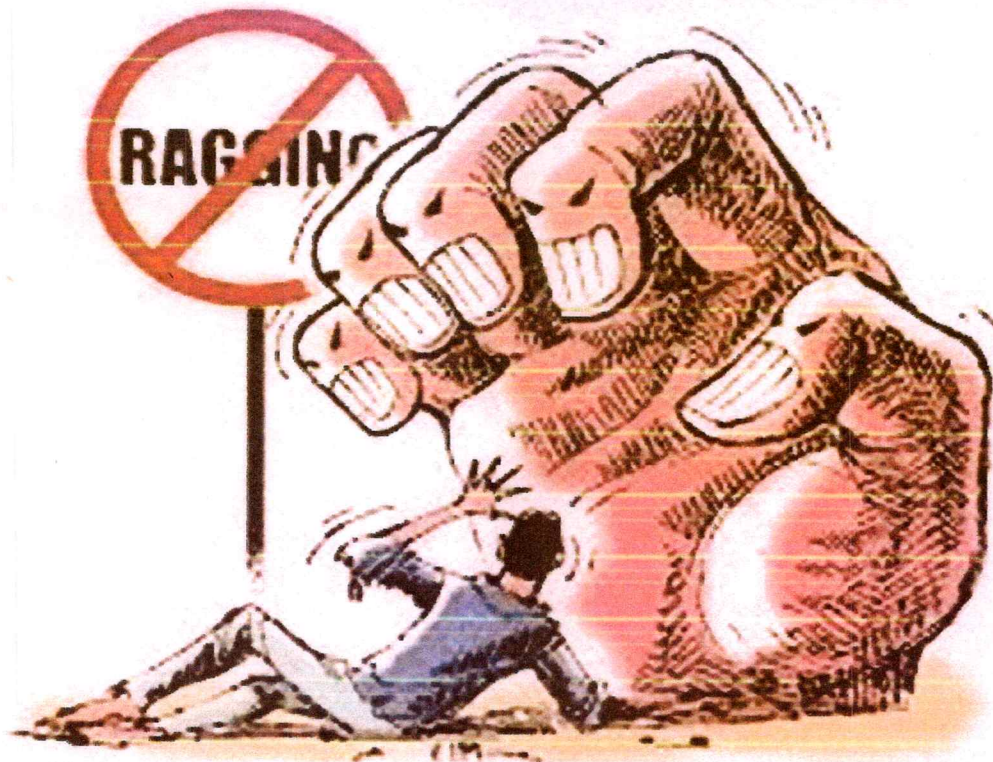

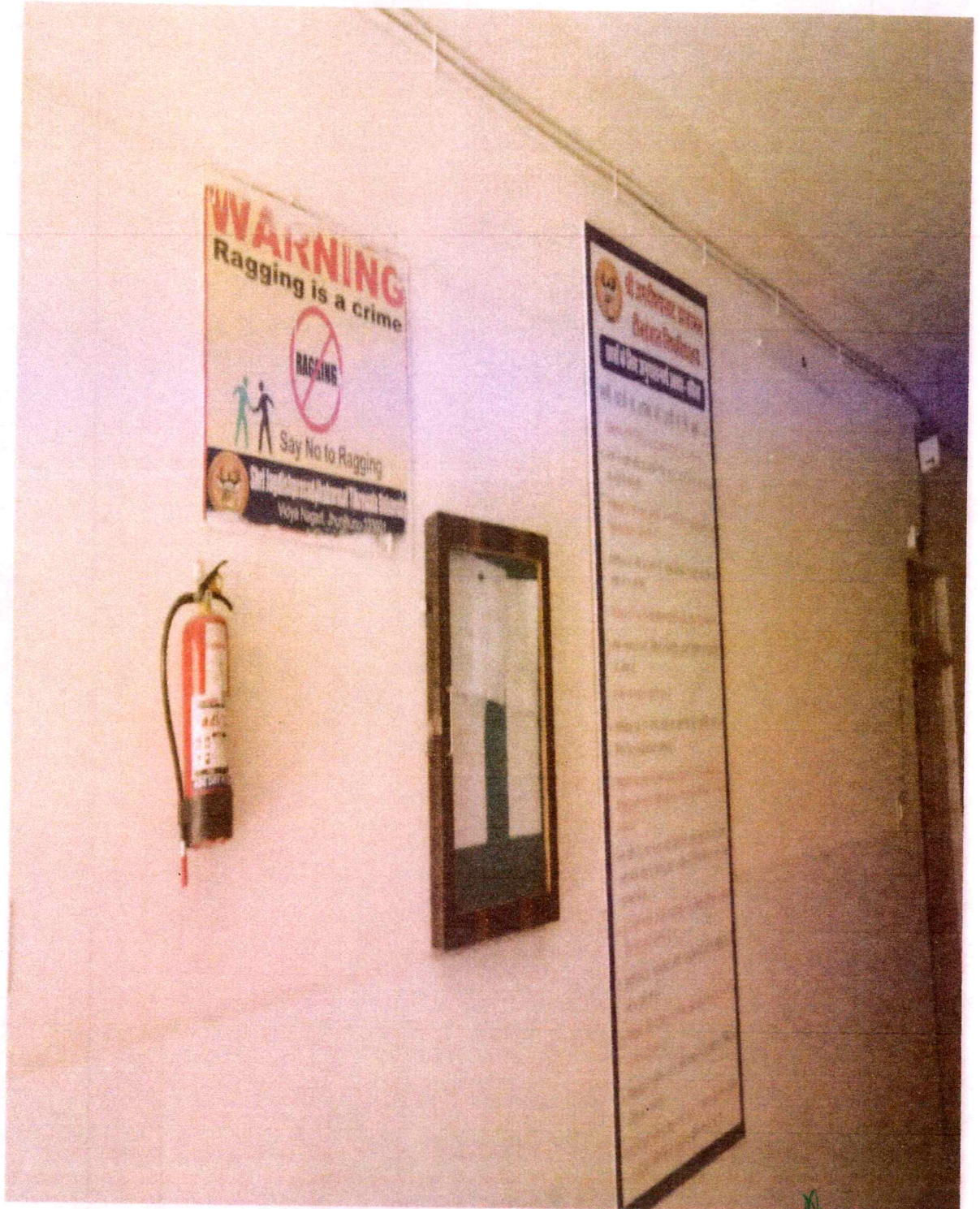

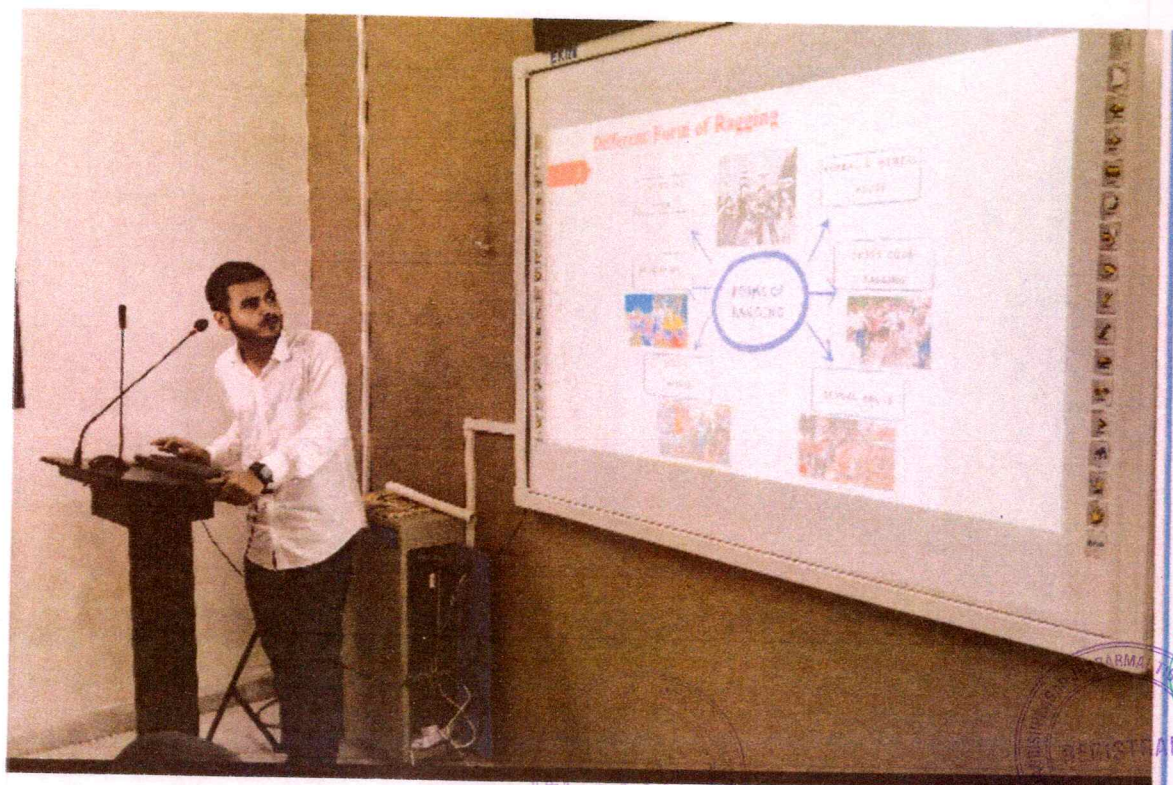

ANNUAL REPORT ON ANTI-RAGGING ACTIVITIES
