Memorandum of Understanding

This Memorandum of Understanding is made on 17th Mar, 2018 between:

(1) **Chairperson, Shri Jagdishprasad Jhabarmal Tibrewala University hereby called (JJTU), Jhunjhunu Churu Road, Chudela, Jhunjhunu, Rajasthan-333001 established by an act of State Govt. in 2009 under section 2(f) of UGC Act 1956. runs Under Shri Rajasthani Seva Sangh hereby called (SRSS), Mumbai a Public Charitable Trust.**

and

(2) **Chairman, Academy for advanced Studies & Training International hereby called (AASTi Academy) whose registered office is at 7 Neeld Crescent, London NW4 3RP, UK**

1. Preamble

Shri Jagdishprasad Jhabarmal Tibrewala University and AASTi Academy agree to form a strategic partnership to undertake jointly a number of educational, training and a range of programmes & activities; on a long-term relationship for mutual benefit.

Mr. Khurshid Alam Chairperson of AASTi is hereby appointed the Director of Overseas education & operations by Shri Rajasthani Seva Sangh, Mumbai with immediate effect from 17/05/2018.

2. Scope

JJTU and AASTi Academy to jointly set up and run on revenue sharing basis (50% share of the profits to be paid to AASTi Academy by JJTU on a quarterly basis) a number of training and academic programmes on a range of subjects. Other Some of the courses and training programmes governed by this MOU are developed by the Academy for advanced Studies & Training International hereby called AASTi Academy. A Joint Certificate/Diploma/ degrees will be awarded by JJTU and AASTi Academy (UK) for all such courses run on a joint or AASTi syllabus courses run by AASTi are developed and owned by the respective qualification bodies in UK. Where relevant the certificates/ Diploma will be awarded by a relevant UK higher education Institutions or awarding bodies with AASTi & such. The courses will be delivered in India with JJTU's resources and faculties under the supervision and guidance of AASTi Academy as stipulated by its associated awarding body. JJTU/SREI will be responsible for total costs of operations and delivery of courses at its centre or its designated centres throughout India as agreed for each course(s) or programme(s). In

addition JJTU will bear the costs of a visiting faculty from UK as and when required by the awarding bodies' terms and conditions. The students/participants enrolled on such programmes/courses will be required to pay the required examination fees and the costs of Diploma/certificate when awarded by UK Institutions . AASTi Academy will be responsible for all costs for development and continued operations of agreed courses/programmes at their end in UK. Where courses/programmes will be fully owned by AASTi Academy or its associated UK Institutions. JJTU will cease to have any involvement with these courses if the agreement is terminated by either party. It is aimed to start the delivery of the following courses with immediate effect but within 3 months signing of the MOU:

- a. A wide range of courses of various durations. The course material will be fully owned by AASTi Academy and JJTU will cooperate fully with AASTi Academy to satisfy the standard of teaching and learning as stipulated by An International level Academy. in some cases courses by bodies to Like ATHE body of UK. Examination will be conducted under the guidelines of ATHE as per their requirements and Diploma will be awarded by them to successful participants. These courses are internationally recognised and offer pathway entries to a number of UK and other western universities for higher qualification.
- b. In 12 months time JJTU and AASTi Academy aims to introduce other courses (UK Higher Education College accredited) in Retail Management , HR, Finance, Investment , Banking, Insurance, Environmental Health and Marketing including additional vocational courses like Beautician, personal Trainer etc.
- c. AASTi to provide UK/international expertise in healthcare and hospital management on fee charge basis to JJTU in offering quality healthcare consultancy and hospital management services to clients in India.
- d. AASTi Academy and JJTU to continually explore other collaborative initiatives for mutual benefits.


An example of programme, courses, training, conference including consultancy/ advisory services:-

1. Post Graduate Diploma in Healthcare Management.
2. Post Graduate Diploma in Strategic Management.
3. Diploma/Certificate course in Nursing/ Nursing Care assistance.
4. Diploma in Primary Technical Training.
5. Setting up a Joint Montessori Teacher Training Academy at SRSS, Mumbai.
6. Diploma in Sports & Events Management.
7. Similar courses in a wide range of subjects with in 3 months.
8. Crash course of Mini MBA mainly for CEOs & Senior Management.
9. Breakfast Seminars with CEOs of leading companies or senior government officials of secretaries level at SRSS Mumbai/ in india or abroad.
10. Organizing 15 days Executive seminars with tourism in the UK and other international venues for CEOs and aspiring CEOs as well as short courses/ seminar of 15 days for Doctors to UK Hospital by AASTi Academy.
11. Organizing leadership, entrepreneurship and medical tourism workshops/seminar/ international conferences in Mumbai or in North India starting from May 2018.


12. Running some add on special British based Skill Development Courses with SRSS (Mumbai) for students aspiring to go to western countries like Australia, Canada & middle east with AASTi added syllabus & including offering consultancies until the end of immigration and or placement.
13. Offering Consultancy & Counselling to those seeking to go abroad the study in reputable university in UK, USA and other western countries/Europe. Including medical students in South East Asia like China at SRSS, Mumbai.
14. Director of Overseas education chairperson of AASTi Academy will be also Senior Member /Advisor of the JJTU and Shri Rajsthani Seva Sangh, Mumbai of senior status to chair meetings as and when necessary.
15. Director of overseas education & operations/AASTi academy chairperson will be provided/ dedicated office with clerical assistance in JJTU & Mumbai Campus at SRSS.
16. Director of overseas education and operation will be provided all necessary facilities like accommodation and travelling expenses connected with his work in India.
17. A reasonable funds will be made available as necessary for marketing and adverting for the collaborative programme as mentioned in above paragraphs.
18. Director of overseas education will be acting as mentor for Ph.D. students in areas of management marketing, law and health care etc.

This list is not exhaustive but an indication of the range and depth of collaborative programmes and activities to be provided and responsibilities and authorities vested with Chairman of AASTi Academy, sufficient facilities provided to enable this happen.

This Memorandum will be valid indefinitely from the date of signature by this Memorandum is governed by relevant law, jurisdiction and arbitration for international collaboration. The Jurisdiction will be in the court of Rajasthan State.
