# Memorandum of Understanding between

The Registrar, Jagdishprasad Jhabarmal Tibrewala University Jhunjhunu, Rajasthan and

The Chairman, Education Wing, Rajyoga Education and Research Foundation, Mount Abu, India

This Agreement is made on11th November,2019 between **Dr. Madhu Gupta** (Hereinaster called Party A) the Registrar, Jagdishprasad Jhabarmal Tibrewala University (JJTU) Jhunjhunu, Rajasthan 333001, and **Dr. B.K.Mruthyunjaya** (Hereinaster called Party B) the Chairman, Education wing, Rajyoga Education and Research Foundation (RERF) having its Administrative head office at Mount Abu, Rajasthan

## THIS AGREEMENT NOW WITNESSES FOLLOWINGS

SCOPE: Whereas Party A and Party B have made an agreement for

a) Offering Various Value Education programs at the Jagdishprasad Jhabarmal Tibrewala University Jhunjhunu, Rajasthan,

b) Starting and maintaining Rajyoga Thought Laboratory at the premises of Jagdishprasad Jhabarwal Tibervala University Jhunjhunu, Rajasthan,

c) The areas of cooperation may include any desirable and feasible activity for the furtherance of the goals of each institution. Such interaction may include cooperation in a variety of joint academic and educational activities such as:

- Meditation, Yoga, Life Science related courses.
- Faculty and student exchange based on reciprocity.
- Joint research projects and publication, including work by undergraduate, graduate, and post-graduate students at the partner institutions.
- Joint conferences and workshops;
- Team taught courses, including online courses; and
- Visits by faculty and professional staff members,

Both the parties (JJTU and RERF) hereby mutually agree to the following terms and conditions:

# 1. Purpose:

The purpose of the MoU is to establish the terms and conditions for offering Various value education programmes and starting and maintaining a "Rajyoga Thought Laboratory" at Jagdishprasad Jhabarmal Tibrewala University, Jhunjhunu, Rajasthan,

## 2. Responsibilities

Jagdishprasad Jhabarmal Tibrewala University Jhunjhunu, Rajasthan, places significant emphasis on academic and professional quality assurance and recognizes this as a major responsibility. In this agreement, both the parties agree to cooperate in the following manner

# 3. Regarding Value Education Programmes

- 3.1. It is JJTU and RERF's responsibility to determine the tuition fees of various value education programmes
- 3.2. It is JJTU and RERF's responsibility to provide state-of-the-art physical infrastructure and other equipment for the successful and quality maintenance of the program.
- 3.3. It is RERF's responsibility to provide academic and intellectual support including academic content (syllabus), course structure (matrix), course delivery methods (pedagogy), guiding students for projects and reports related academic deliverances.
- 3.4. It is JJTU and RERF's responsibility to conduct examination and to setup evaluation pattern/assessments.
- 3.5. It is the responsibility of JJTU and RERF's to carry out all activities related to marketing including promotion and advertisements for the programs under the purview of this agreement.
- **3.6.** All fees of the value education programmes offer under the purview of this agreement shall be collected by the university only.

- 3.7. Sharing of collected tuition fees will be based on actual student enrolment numbers on confirmation of enrolment and the percentage of sharing will be worked out separately.
- 3.8. Students/Candidates who enrol into the joint program of JJTU and RERF shall be awarded by the Jagdishprasad Jhabarmal Tibrewala University Jhunjhunu, Rajasthan, on a successful completion of various programmes.
- 3.9. Party-B will take care of the conduct of theory and practical classes for the value education programmes, as per the schedule approved and signed by both the parties.

# 4. Regarding "Rajyoga thought Laboratory"

- 4.1 It is the sole responsibility of Party A to construct or allot the required space for establishing the "Rajyoga Thought laboratory" at the campus of Party A
- 4.2 It is RERF's responsibility to provide technical support and resources /advice to Party A for both establishing and maintaining the "Rajyoga Thought laboratory"
- 4.3 Party-B will take care of only the technical support and resources / advices for the successful implementation of the "Rajyoga Thought laboratory" including counselling assistance to the beneficiaries such as teaching, non-teaching staff and students of the University.
- 4.4 Party B will not incur any financial assistance either in establishing or maintaining the laboratory. However incidental expenses from time to time will be bear by the Party A by mutual consent.

# 5. Coordination & Communication:

Each party shall designate a competent Co-ordinator to develop and coordinate the activities as agreed upon herein this agreement and later in the program specific schedule. The Director, Value Education Programmes of Party B's HQ will correspond to the university on all policy decisions and procedure to be followed for the success of collaborative programmes.

## 6. Exchange Visit of Leaders

In order to coordinate and for the cooperation, both the parties agree to exchange visit(s) of leaders on the basis of necessity and reciprocity.

# 7. Understandings, agreements, support, and resource needs:

RERF shall provide all the required support and resources to the students of the value education programmes under the purview of this agreement.

#### 8. Review and Evaluation of outcomes:

Both the parties (JJTU&RERF) will review and evaluate the outcomes of joint activities at the end of each academic year, and shall make recommendations for the further development.

#### 9. Fiscal Control:

Jagdishprasad Jhabarmal Tibrewala University (JJTU) Jhunjhunu, Rajasthan, will solely keep a hold on fiscal control through their respective business offices.

## 10. Modification of Agreement:

Revisions or modifications may be proposed at any time, which will be effective only after the date of written agreement signed by both the parties.

## 11. Resolution of Disputes:

11.1. In the event of any dispute or grievance, a joint committee will review the issue and reach an amicable solution. If the committee cannot resolve the issue, then, it will be referred to the higher level authorities of both the parties in progression. If the agreement is still not reached then the terms of the MoU may be reviewed to determine the next course of action including a termination of the MoU.

11.2. In the event of the termination of the MoU, all the parties shall work together in the best interests of the students enrolled into the joint programs.

#### 12. Termination Clause:

Any party may terminate the Agreement with twelve (12) months of advance notice in writing, unless an earlier termination is mutually agreed upon.

#### 13. Duration of MoU:

This Agreement is valid for five (5) years from the effective date.
