MEMORANDUM OF UNDERSTANDING

I.P.PAVLOV RYZAN STATE MEDICAL UNIVERSITY

SHRI JAGDISHPRASAD JHABERMAL TIBREWALA UNIVERSITY

This memorandum of understanding (MOU) summarizes agreements between I.P.Pavlov Medical State University Ryzan (OSU) and Shri Jagdish Prasad Jhabermal Tibrewala University (JJTU) to cooperatively promote successful youth, cultural exchange and educational experiences for students who attend both the respective university. We are entering into this MOU to better serve students and to mutually benefit our institutions. The following understandings will guide this effort, until modified or amended.

- 1. In recognition of this key element, the institutions agree as follows:
 - a) Youth and Cultural Exchange Programs.
 - b) Chancellor of RSMU to be an Hon Prof/Consultant of JJTU.
 - c) Parties to this MOU can use each others name on Promotional plans and materials and organize seminars in Russia and in India.
 - d) Access to E-Library on reciprocity.
 - e) Dual degree Certificate/Programs, Distance Learning Center, Faculty and student exchange Programs and for other Departments separate Agreement to be entered by and between the Parties.
 - 4. The exchanged faculty member and/or the home institution shall be responsible for the cost of transportation to and from the host institution.
 - 5. Exchange faculty shall be responsible for obtaining any necessary visas and otherwise complying with all immigration laws and regulations of the country of the host institution.

The host institution shall cooperate in such efforts but shall not have any responsibility to assure the granting of any visas, permits, or approvals.

- 6. The home institution shall also provide for accommodation in the University.
- 7. Unless otherwise provided in the applicable Exchange Contract, each exchange participant must submit, prior to departure from the home institution, proof of Medical, Health, and Repatriation insurance coverage for the duration of the exchange period as required by the law of the country of the host institution.
- 8. Should any faculty collaborations result in the potential for intellectual property, representatives of the institutions shall meet as soon as practicable to seek a fair and equitable understanding as to ownership and/or any other property interests that may arise in regard to the intellectual property. Any such discussion shall at all times strive to preserve a harmonious and continuing relationship between the institutions.

The purpose of this MOU is to record the understanding and commitment of the two parties to promote and strengthen an exchange program. Specific contracts regarding exchanges of faculty or activities and/or initiatives shall be completed as separate agreements. In such instances, the agreements shall be in writing and signed by authorized representatives from each of the parties.

Terms and Termination

- A. This agreement shall not create any rights in any third parties, specifically any students participating in the program. The only parties to this agreement are RSMU and JJTU.
- B. This MOU becomes effective upon signature by both parties.
- c. Amendments to this agreement must be in writing and approved by the designated representative of each institution.
- written notice to the designated representative at least 90 days prior to the commencement of a new academic term. With the understanding that any other agreement then in progress shall be completed according to the provisions of the other agreement.
