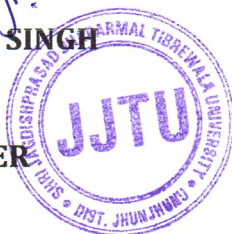

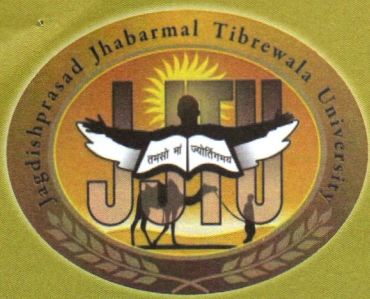

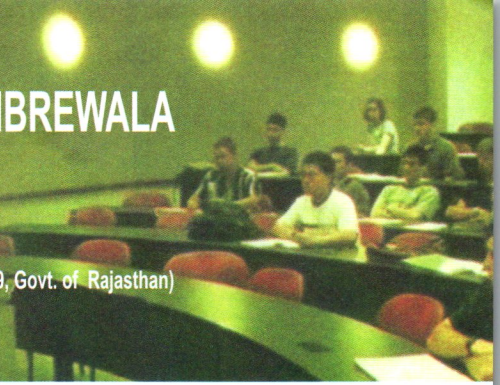

Discussion about applying for Proposal for participation of Shri Jagdishprasad Jhabarmal Tibrewala University in National Academic Depository (NAD):** NAD is refer to National Academic Depository, and discussion made on placing detailed to apply for NAD proposal, it will help Students, Higher Education Institutions and Employers to access degree certificates of candidates, it is proposed to establish a Digital Depository for School Leaving Certificates, College Degrees, Academic Awards and Mark sheets, on the pattern of a Securities Depository. As per this proposal the Government of India is committed towards bringing administrative and academic reforms through the use of technology for delivery of efficient services to all stakeholders. Towards this end, Government intends to establish a Digital Depository of Academic Awards to be known as National Academic Depository (NAD) on the

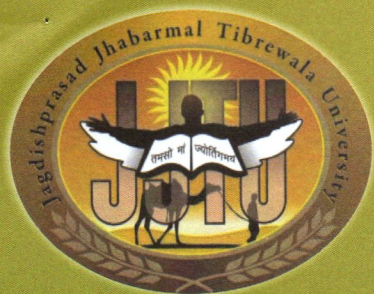

At present Users can view the availability of reading material in the library in print as well as electronic format. The full text material in electronic format is attached with the bibliographical details and with a single click; the users can view the whole document on the screen. The University Library is centrally located in a circular designed in MBA Block. The Library has Reading Halls with a total capacity of 120 seats. The University Library has added 500 books to its existing collection of 26000 books during the financial year 2016-2017 with 40 magazine 70 journals now the library has a collection. The Library functions in one shift from 9.00 a.m. to 5.00 p.m. and e-library remains open to 7:00 p.m. from Monday to Saturday.
